## **RULE PROPOSALS:**

### **Western Horsemen of Oregon Rule Proposals 2016**

#### ***New Rule Proposal – 1 (Submitted by Tom Delker)***

No W.H.O. show can be changed to new location after the show has been approved and posted. This must have the majority of the board to move the show. This is the W.H.O. Junior show, the Summer Show, and any Princess show that W.H.O. puts on.

**New Rule Proposal – 2** (Submitted by Tom Delker)

No child under the age of three will be allowed in the Pee Wee Classes.

Reason: Safety factor; unless the child is able to hold on the horn or the horse by himself or herself and not be held on by the adult.

**New Rule Proposal – 3**

Children under eight years old are not allowed in the arena without a parent or adult.

Reason: Too many unattended children are gathering in the arena. One of the past weekends alone there were two incidents where a child ran out on course.

**Rule Change Proposal –1** (Submitted by Stacy Hardin)

Once a class has started, you can only be added to the open class.

Current Rule: No entries may be made to a class once that event has started.

Reason: Open points don't count. If someone has a rough go in their class, they can do it again to clean it up. Will also bring in more money for W.H.O.
